8. Reports from Staff & Others

a. Road's Department Report

The Road Superintendent reported this month has brought a lot of water damage to Casey Mine Road due to melting. A few loads of gravel were hauled to Casey Mine Road to help smooth things out and a few culverts were thawed with the steamer. The Road Superintendent has started grading roads, beginning with the roads that required it most. A resident mentioned that they would like the ditches cleaned out on Jelly North Road. Council agreed to continue discussions regarding road maintenance, ditching, and brushing once the 2021 budget is approved.

Ducks Unlimited has requested approval to install a temporary access near the outflow of the Marsh. There is currently a permanent entrance on Pennashaft Road. Office staff have included a memo to Council in regards to this request which will be dealt with separately.

The Township of Brethour has requested work (brushing and ditching) on River Road as well as Lafond Road. Guy Labonte spoke to the Reeve of Brethour regarding these boundary roads. Guy Labonte and the Reeve will continue to meet and discuss these roads after the 2021 budget is approved. At that time, they will also discuss the replacement of a boundary bridge. Council directed the Clerk-Treasurer to inform Brethour of their decision to ensure they're kept informed.

b. Fire's Department Report

The Fire Chief reports that several Fire Fighters have received their first dose of the Moderna vaccine under the first response group. They have also received a one-time grant of \$4,600.00 from the Solicitor General. The grant will be used for DZ training, the purchase of a mannequin for rescue practices, and the purchase materials to build props for training.

As per the Timiskaming Health Unit and Enforcement Officer, the Fire Department is permitted to gather for training under current restrictions. Regular meetings and practices will continue and COVID precautions will be applied.

Fire restriction is in effect as of Monday, April 12th. No new permits are to be issued. Campfires are allowed.

Casey Fire Department received one mutual aid call from the Township of Harley to assist with an outdoor fire along Highway 11.

b. Snow Removal– March 29th Snow Fall

The Clerk-Treasurer informed council that the municipal office received various complaints from residents throughout the day of March 29th regarding the timeliness of snow removal. One resident contacted the municipal office on several occasions and has requested this matter be brought up to council for review, specifically relating to the current route and Snyder Road.

Council directed municipal staff to inform the resident that during snowfalls such as what occurred on March 29th, the township ideally operates two plow trucks. However, due to staffing issues, only one plow truck was operating. The Road Superintendent also informed council that they had a late start, and once they did start plowing, due to the recent warm weather and thaw, they had to operate at slower speeds to avoid damaging the roads.
