#### a. Road's Department Report

The Road's Superintendent reports that the summer student has finished his contract. Lots of grading was done in the month of September. Don Adshead finished hauling 2,500 tonnes of gravel to Maybrook Rd. Completed ditching both sides of Greenwood Bridge Road. The municipal dock is out of the river. A couple loads of gravel were added on Lafond Road. OCWA has started treating the lagoon with ferric sulphite and it should be good to start discharging shortly after October 15<sup>th</sup>. A new tire for the lawn mower was purchased. Adshead's price for winter sand: \$8.45/ton delivered to the shop. Connor's price will be provided to Council when it is received. Ray & Sons came to inspect the stormwater drains located within the village. 50 feet of tile has been changed so far, due to plugging. Ray & Sons will continue to test the drains in sections to ensure there is no more plugged sections.
