8. Reports from Staff & Others

a. Road's Department Report

The Road Superintendent reports that he has been ploughing and sanding on a regular basis. New blades were ordered for both plow trucks. The nozzle on the clear fuel tank has been changed. The Zamboni has been serviced. The plates for truck 7 and 9 have been renewed. Truck 7 needed an emission test. A resident has a dump truck parked in the middle of the turnaround on Penna Shaft Road which is Township property. There is also a vehicle parked on Frontiere Road. Both vehicles are making it difficult to remove snow. The municipal office will issue letters to these specific residents.

Due to the procurement of a new Freightliner Plow truck, council unanimously agreed to surplus the old 1989 International plow truck, to be sold for \$2,500, as is.

b. Fire's Department Report

Fire Chief reported no calls for last month and that training and meetings were cancelled due to COVID-19. A report was filed with 5th Wheel Training for damage that occurred to the firehall garage door while training volunteers. The instructor from 5th Wheel Training backed into the garage door.
