a. Road Department Report

The Road Superintendent reports that Lathem Construction brough gravel and graded it but it did not pack down well on Belle Vallee Road. Adshead brought gravel for the village and the roads were graded. There were a few extra loads of gravel so it was spread on Belle Vallee Road to help pack. Troubleshooting on the Lachapelle storm drain and dug out the sink holes, dumped water to check flow and repaired as needed. Grading was done when time permitted. A few sections of guiderails at the end of Belle Vallee Bridge were repaired. We had beaver dams on Sales Barn Road. Regular maintenance on machinery was completed. OCWA collected samples of the lagoon and will be advised when results come in.

- 2022-117 **Moved: Janet Little Seconded: Suzanne Boucher**WHEREAS, the Electoral Boundary Commission has proposed to remove on of the electoral ridings from Northern Ontario; and

WHEREAS, the proposal to diminish Northern Ontario's voice in Parliament will have a detrimental effect on participatory democracy and regional development as the issues in Northern Ontario are significantly different than the issue facing the urban south; and

WHEREAS, the Federal Boundary Commission proposal to cut representation in the north is contrary to the 2017 electoral boundary changes for Ontario that recognized the need to add two seats to ensure fair participation for northern residents; and

WHEREAS, many of the existing ridings in Northern Ontario are already larger than many European countries, a situation that will only be worsened by the addition of massively new regions to service; and

WHEREAS, the proposed new super ridings will force municipalities to compete for a limited amount of riding funding which will further exacerbate inequities in the north; and

WHEREAS, Northern Ontario's population per riding is already much higher than many other rural and isolated regions in Canada's north; and

WHEREAS, the courts have ruled that representation in Canada's democracy is not based merely on population but on regions of interest and the right of citizens to engage with their elected representatives; and

WHEREAS, any changes to electoral boundaries should be based on the principles of maintaining communities of interest within boundaries that are equitable in terms of population and geography;

NOW, THEREFORE BE IT RESOLVED that the council of the Township of Casey calls on the Electoral Boundary Commission to maintain the electoral representation of Northern Ontario and ensure that any boundary changes are done in a manner that responds to regional and local needs. "CARRIED"
