4. Delegations:

a. Brad Bauman:

Brad Bauman attended to make council aware that in regards to his plans to run an abattoir on his property, he had a pre-submission meeting with J.L. Richards to discuss what studies he would need to submit with a zoning by-law amendment application in order for it to be complete. Mr. Bauman asked Council two questions that came out of his pre-submission meeting. Municipal Staff provided answers to Mr. Bauman's questions, noting that a zoning by-law amendment application is required as an Abattoir is not a permitted use under the Township's zoning by-law. However, Provincial Policy Statement would support a zoning by-law amendment application for an Abattoir as it aligns with provincial policy. Additionally, Mr. Bauman asked Council if a hydrogeological and terrain analysis had ever been requested in the past. It is likely that such request has not been requested previously, as it would only be requested in situations where there is potential for significant water usage. Studies and analysis's requested by the planner come from data and information provided by the applicant during the pre-submission meeting as well as other application policy statements. Municipal Staff explained the steps in

the process which include submitting an application with required studies/analysis's, posting notice of the complete application for public notice and notice of public meeting before a decision can be made. Some questions were raised by attendees asking if odour was a concern. Council confirmed that they have received complaints about noxious odours coming from the existing abattoir. Mr. Bauman asked Council if they would waive the studies recommended by the Planner. Council and staff noted that if the recommended studies were not provided as per the Planner's request, the Planner may be unable to provide a positive recommendation for this type of zoning application. Mr. Bauman suggested different ways to deal with the waste and would like to know if these changes would affect the need for an odour study. Municipal staff made Mr. Bauman aware that they would pass along these questions to the planner if he provided them to the staff. An owner of Leis Landscaping expressed the importance of having an abattoir in the area to support other local businesses such as poultry feed stores, and thanked Council for listening to their concerns and desire to see this business be successful. Reeve Labonté expressed to all members present that Council supports farming and small businesses development within the Township of Casey.
