The Road's Superintendent reports that regular maintenance was performed on equipment. Grading operations happened when weather allowed. Calcium is scheduled for June 19<sup>th</sup>. There were several beavers that caused some issues. Most have been taken care of now. Village Roads, intersections and bridges were swept. Holes were patched where necessary. Trees were removed at the park and the municipal dock was also installed. The ball field is being used twice a week. Demora pulverized Pearson and Omer and will be completed shortly. A culvert was installed on Promenade Road. The Superintendent closed the road to perform this maintenance and several vehicles ignored the barricade of road closure. Office staff will work with the Road Superintendent and Doug Walsh from EXP to issue a tender for a single application of surface treatment on the village roads.
